- This application is for ALL CPYC members requesting drystall space for the upcoming summer season of April 15 - Nov 15, 2016.
- You must apply, even if you are a member with a previously assigned drystall space.
- 2016 drystall stickers will be distributed upon receipt of your payment, and applied to your trailer or dolly. Stickers are required for ALL boats stored at the club so that they can be identified.
- Spaces will not be assigned to members who are posted or suspended for delinquent bills.
- Space requests made on an as-available basis only.
- Requests for drystall space for non-one design boats will be considered only on a space available basis and only with prior approval of the Board of Governors in accordance with House Rules.
