



# CPYC BASIN STORAGE - SUMMER 2018

**Request for Basin Space – Deadline for Submittal March 15, 2018**

- This application is for ALL CPYC members requesting basin space for the upcoming summer season of April 15 - Nov 15, 2018.
- You must apply, even if you are a member with a previously assigned basin space (including Atlantic owners).
- Basin assignments will be made based on applications received, with payment and proof of insurance.
- The application must be accompanied with a 50% deposit for the season's basin storage fees to be considered.
- Balance payment is due prior to arrival into the CPYC Basin.
- Basin space will not be assigned to members who are posted or suspended for delinquent bills.
- Vessels left in the basin after Nov. 15, who do not apply for winter storage, will be charged a daily storage fee consistent with the winter storage rate in effect.
- Please refer to "Berth Assignments" in the club roster for details of all rules and regulations.
