- This application is for ALL CPYC members requesting basin space for the upcoming summer season of April 15 - Nov 15, 2019.
- You must apply, even if you are a member with a previously assigned basin space (including Atlantic owners).
- Basin assignments will be made based on applications received, with payment and proof of insurance.
- **Payment of 50% of Total Fees is required with your application in order to be considered. Remaining balance is due by May 1, 2019. To reduce costs, full payment with this application is encouraged.**
- Basin space will not be assigned to members who are posted or suspended for delinquent bills.
- Vessels left in the basin after Nov. 15, who do not apply for winter storage, will be charged a daily storage fee.
