**Request for Drystall Space – Deadline for Submittal May 1, 2009**

**Boats will be ASSIGNED a specific SPACE in the Drystall area.**

- o Please fill out the table below for each hull for which you are requesting a drystall space.
- o 2009 Drystall Stickers will be mailed upon receipt of your payment, with instructions for its application to your hull, trailer and dolly. Stickers are required for ALL boats, trailers, and dollies stored at the Club so that they can be identified.
- o Working with your Fleet Captain, indicate on the form the space in which your boat will be stored. Under House Rules, One Design Fleet assignments are made only within designated rows assigned to each Fleet as determined by the Fleet Captain
- o Spaces will not be assigned to members who are posted or suspended for delinquent bills.
- o Assignments will be posted at the club by May 15. Changes or swaps after May 15 require approval of your Fleet Captain and notice to the Governor in Charge of Summer drystall assignments, John Cooke.
- o Space requests made after June 1 will be granted on an as-available basis only.
- o Requests for Drystall Space for non-one design boats will be considered only on a space available basis and only with prior approval of the Board of Governors in accordance with House Rules.
