



# CPYC DRYSTALL STORAGE - WINTER 2019-2020

**Request for Drystall Space – Deadline for Submission is November 1, 2019**

- This application is for both CPYC members and non-members requesting drystall space for the winter season of November 15, 2019 – April 15, 2020.
- **To be assigned a space, you must include (1) full payment if you are not a CPYC member or 50% payment if you are a CPYC member (100% with application is appreciated), and (2) a copy of the declarations page of your boat insurance policy. These are required even if you have been previously assigned a space.**
- Drystall space is for boats arriving and stored on trailers only.
- Space will not be assigned to members who are posted or suspended for delinquent bills.
- All boats in the drystall must be clearly marked with a registration number or name and registered with the Club Manager upon arrival at the club. Failure to comply will result in additional fees up to \$300.

**I understand and agree that:**

- My boat must be stored on a trailer. Use of boat stands, poppets, blocks or jacks is not permitted.
- CPYC does not provide boat hauling, blocking, winterizing, shrink-wrapping, engine or other boat maintenance services.
- CPYC is not responsible for maintaining a watch or otherwise caring for my boat while at CPYC.
- I understand that CPYC is a seasonal club with limited staff during the winter storage season, and that my boat may be inaccessible at times due to snow and ice.
- I authorize any CPYC Governor, staff member or their designee at their discretion, to board and enter my boat and to take such emergency measures as they deem necessary. Should such action be required they will attempt to notify me using my contact info above as soon as practicable. CPYC may cut the lock on my boat to accomplish entry if necessary. I agree that I shall be responsible for all expenses arising out of or resulting from any such measures and that CPYC shall have no obligation to undertake any repairs or assistance.
- I shall maintain liability and hull insurance for my boat during the storage period.
- Contractors engaged to work on boats must check in with the Club Manager before beginning work and shall provide proof of General Liability Insurance with limits of \$1,000,000 per occurrence / \$2,000,000 aggregate and Ship Repairer's Legal Liability with limits of \$1,000,000.
- Discharge of fuel, lubricants or pollutants of any kind on shore or into the basin is strictly prohibited and I accept full legal responsibility for any such discharge. I will immediately report any such discharge to the Club Manager.
- No heaters are permitted in my boat during storage and that power is not provided in the drystall or parking lot.
- Owners of boats left in the drystall after April 15, 2020 who do not apply for and receive a space assignment for the summer season will be charged a daily storage fee of \$3.00 per foot per day.
- I assume full responsibility for my boat while at CPYC, and I hereby release and hold harmless CPYC from any liability for personal injury or damage of any kind.
